

## Plaques & Prizes

1st, 2nd and 3rd place plaques will be awarded for:

Children age 15 and younger will be given plaques for Biggest fish (Trout or Bass) and Heaviest stringer.

## Tournament Rules

Minimum size for “keepers” is 8 inches.

A valid fishing license is required with a limit of 4 trout in possession. (Children 9 or younger are limited to 2 trout).

Fishing is limited to Willow Springs Lake.

Fishing will take place rain or shine.

Final decisions will be made by the Tournament Director.

Registration opens at 5 AM and closes at 7 AM.  
Pre-registered entries MUST sign in by 7 AM.

Weigh-in begins at 3 PM and closes promptly at 4 PM. Weigh-in will take place at the Let’s Talk Fishin Stage Trailer.
