

Plaques & Prizes

1st, 2nd and 3rd place plaques will be awarded for:

CATEGORY #1: Any species Trout. Adult limit is 4; Children age 10 and younger limit is 2.

CATEGORY #2: Large and Small-mouth Bass (no limit).

CATEGORY #3: Children age 9 and younger will be given an award for 1st, 2nd and 3rd place for the largest fish caught, Trout or Bass.

DONATIONS for Raffle Tickets (\$1 ea.) will be accepted throughout the day. The raffle drawings for terrific Prizes and also the Trophy Awards ceremony will begin promptly at 2 PM following the weigh-ins. (Plaques will be held for anyone not present for awards).

Tournament Rules

Minimum size for "keepers" is 8 inches.

A valid fishing license is required with a limit of 4 trout in possession. (Children 10 and older need a Youth License. Children 9 or younger are limited to 3 trout, unless they have a license).

Fishing is limited to Willow Springs Lake.

Fishing will take place rain or shine.

Final decisions will be made by the Tournament Director.

Registration opens at 5 AM and closes at 7 AM. Pre-registered entries MUST sign in by 7 AM.

Weigh-in begins at 1 PM and closes promptly at 2 PM. Weigh-in will take place at the Let's Talk fishin registration area.
